a. Teema

a. Subject

1. Teavitamine Tuuletraal OÜ 700 - 1000 MW (2 miljardit €) meretuuleenergia projektile vajaliku keskkonnamõju hindamise teenuse osutamise ebaseaduslikust blokeerimisest.
2. Ettepanek blokaadi esiie kutsunud võimsa rahvusvahelise kriminaalse elemendi Eestist välja saatmiseks.

1. Information of unlawful blockade regarding provision of Environmental Impact Assessment services to Tuuletraal Ltd 700 - 1000 MW (2 Billion €) offshore wind energy project.
2. Proposal to banish the powerful international criminal element that is responsible for the unlawful blockade.

b. Sissejuhatus

b. Introduction

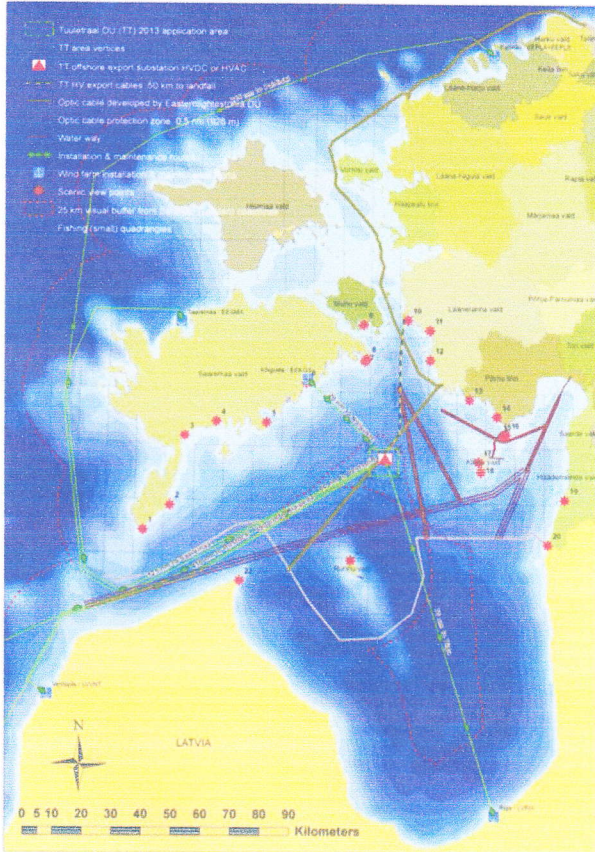
Tuuletraal OÜ ja selle eraisikust omanikud Eero Saava ja Sven Aasa on rahvusvahelise valgekraede poolt juhitava kriminaalse grupeeringu (Majandusmõrtsukad) poolt vaenuliku ülevõtmise rünnaku all alates aastast 2014, st üle 10 aasta. Tuuletraal OÜ arendab alates aastast 2013 projekti akvatooriumi suurusega 91 151 886 m<sup>2</sup> (ca 91 km<sup>2</sup>) Läänemeres, asukohaga:

Tuuletraal Ltd and its private owners Mr. Eero Saava and Mr. Sven Aasa are under hostile takeover attack by international white-collar crime group (Economic Hitmen) since year 2014, i.e. over 10 years. Tuuletraal Ltd develops since year 2013 a project with 91 151 886 m<sup>2</sup> (ca 91 sqkm) area in the Baltic Sea, located at:

Projekti asukoht Liivi lahes:

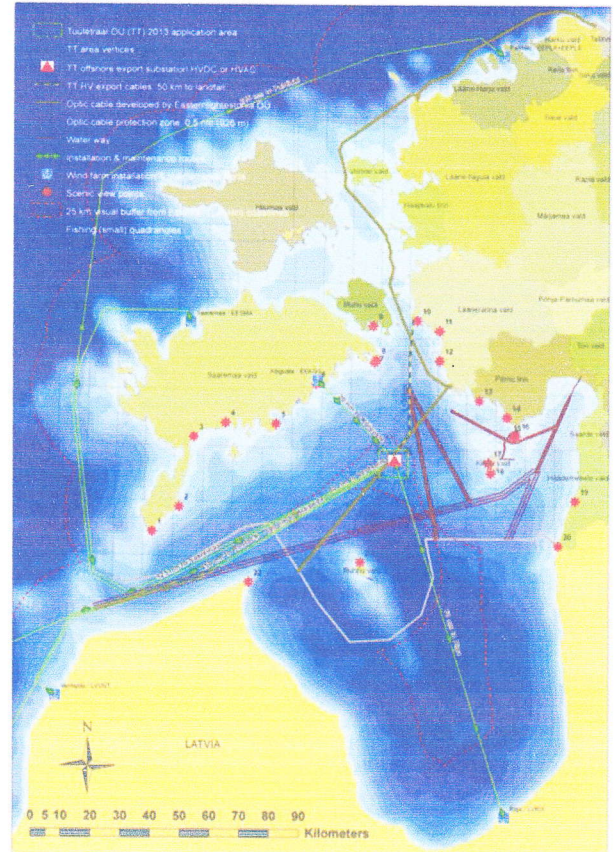


Projekti elektriline võimsus on 700 MW, ametliku laiendamisvõimalusega 1000 MW-ni. Projekti keskkonnatingimused on unikaalselt soodsad ning investering ei vaja Eesti riigi ja maksumaksja abi hinnapõrandate ja subsiidiumite näol, kuna:

- Kaugus kõikidest rannikutest üle 25 km
- Suur keskmine tuulekiirus ja kõrge tuule kvaliteet (vertikaaljaotus, turbulents) rootori töotsoonis
- Mere sügavus 20 - 30 m ja sobilik vaivundamendi jaoks sobiva pinnasega
- Liitumispunkt on 50 km kaugusel ja elektrikaablite trassid on väga hästi kaitstavad terroristlike rünnakute eest

Me usume kindlalt, et Majandusmõrtsukad taotleksid edukalt, Tuuletraal OÜ arendusaia vaenuliku ülevõtmise järgselt, Eesti riigilt ehk maksumaksjalt kuni 2,6 miljardit € riigiabi, mis tegelikkuses läheks täies ulatuses Majandusmõrtsukate üleliigseks kasumiks.

Project location in Gulf of Riga, Baltic Sea:



Project's electric capacity is 700 MW with official extension option up to 1,000 MW. The environmental conditions of the project are uniquely favorable and the investment does not need any subsidies (price cushion etc.), because:

- Distance from all shores more than 25 km
- High average wind speed and wind quality (vertical shear, turbulence) over the rotor swept area
- Sea depth between 20 - 30 m and the soil is suitable for mono-pile substructure
- Onshore grid access is 50 km away and the cable routes are well protected from terrorist attacks

We firmly believe that the Economic Hitmen, after succeeding at Tuuletraal Ltd project's hostile takeover, would apply for subsidies and grants from Estonian State and taxpayers up to 2.6 Billion € of state aid that will subsequently transform in to excessive profit.

c. Teenuse blokaadi lühikirjeldus

2024 aastal viis Tuuletraal OÜ läbi 2 hanget keskkonnamõjude hindamise juhteksperdi leidmiseks. Mõlema hanke käigus saadeti pakkumise kutse eranditult kõigile litsentseeritud juhteksperptidele, st isegi konkurentide jaoks töötavad eksperdid said kutse. Hange #1 tellitav töömaht oli suhteliselt suur. Niinimetatud kordushange #2 tellitav töömaht oli muudetud suhteliselt minimaalseks, et maksimeerida pakkujate huvi. Hangete käigus sai Tuuletraal OÜ pakkujate tervikpildina väga ebaloogilise tagasiside. Nii #1 hanke kui ka #2 kordushanke lõppfaasis jäi pildile üksainus pakkuja, vastavalt XXX OÜ (hange #1) ja YYY OÜ (hange #2). XXX OÜ ja YYY OÜ on selge omavahelise juriidilise seosega. Nii XXX OÜ kui ka YYY OÜ tegid Tuuletraal OÜ-le - ainsa pakkujana jõupositsioonil olles - ettepaneku hanke lähteülesanne kardinaalselt ümber kirjutada. Tuuletraal OÜ mõlemal korral ei nõustunud ja luges hanked ebaõnnestunuteks.

d. Majandusmõrtsukate üldised meetodid

c. Short description of the unlawful blockade of the services

Year 2024 Tuuletraal Ltd carried out two (2) procurements to find a lead expert for Environmental Impact Assessment Committee of Experts. For both procurements, all (i.e. 100%) Estonian expert-license-holders were invited to respond to the RFP (Request for Proposal), inevitably also including anyone actively working for direct competitors. RFP #1 was characterized by relatively large scope of work. So-called repeat-RFP #2 had a much smaller scope to maximize willingness to respond. The incoming responses painted a general picture that was very illogical. During both RFPs, a single contestant remained - XXX Ltd for #1 and YYY Ltd for #2, respectively. Between XXX Ltd and YYY Ltd exists a clear legal connection. Both XXX Ltd and YYY Ltd requested - exploiting their position as the single contestant - cardinal changes in the underlying scope document for the RFP. In both cases, Tuuletraal Ltd did not yield and deemed both RFPs as having failed.

*Hi, Professor Wolff, how are you?*

■ Mr. Richard D. Wolff (Guest)

*Very good, I'm very glad to be here.*

■ Amr Waked

*What can you tell me about the so-called economic hitmen and corporations or institutions that strangle countries' economies?*

■ Richard D. Wolff

*First of all, it happens all the time. It is nothing new. It is not rare. It is common.*

■ Amr Waked

*So somebody from a powerful corporation goes and ...*

■ Richard D. Wolff

*... will sometimes connect to a local equivalent of himself and cut a deal and say: 'Look, I'm going to get paid \$10 million for getting this done. I will give you \$2 million if you become my local eyes and ears to help me work this out'.*

■ Amr Waked

*Forgive me if I will sound naive. Isn't the country receiving this loan participating willingly in this terrible deal?*

■ Richard D. Wolff

*Happens all the time. People from Third World countries can get into that because they understand this game and they get the job because they say: 'I know better about the details of local politics'. And by the way, it often fails. Don't imagine it's all so smooth. Sometimes one of these people will get drunk and say the wrong thing to the wrong person. Sometimes a local official will have a change of heart and want out of this situation. Sometimes people who take a fortune then get blackmailed by somebody else who knows they did that and now they have to get out of that. International credit is a very complicated, sneaky, personal business that can have all the different twists and turns that you can imagine.*

*Sometimes we have whistle-blowers, people who speak up out of principle. This could change things actually, right?*

■ Richard D. Wolff

*The only answer I can give you is that everything has been done, imaginable, to KEEP THIS GAME GOING. And one of the most important things is that when you get caught either nothing is done or one or two individuals are punished, but you never change the basic system. And let me be for a moment the advocate of the banker who initiates this. That banker knows that if he can work three or four big deals, one in Ecuador, one in Mali and one in Malaysia, he will be promoted to the president of the bank. That's how you succeed in the bank. They don't care how you do it. You shouldn't embarrass the bank, of course, but your job is to GET THAT LOAN DONE! So if you don't because you are honest or you have scruples you are shooting yourself in the foot. You are destroying your own career. So often you will, if you know these people they will tell you they have no choice. But it's important for people to understand THIS IS A SYSTEMIC PROBLEM.*

**Operatsioon RE (27.11.2014 - tänaseni)**

Agendi nimi: P.I.

Koosseis: Ebaseaduslik jälitustegevus ja teabe varjatud kogumine karistatav kolmeaastase vangistusega seoses #31 (Karistusseadustik §315); Tõendi kunstlik loomine karistatav viieaastase vangistusega seoses #25 and #31 (Karistusseadustik §316)

**Operatsioon OR (15.10.2021 - 12.11.2021)**

Agendi nimi: W.K., X.X.

Koosseis: Koostada kompromiteeriv materjal nagu Eero Saava oleks süüdistanud 10.11.2021 pooleteist tunnise kohtumise käigus Kaitseministeeriumit korruptsioonis; Eero Saava reageeris vahetult juhtunule 12.11.2021 kirjaliku pöördumisega Siseministeeriumi ja Kaitseministeeriumi poole. 12.11.2021 kirja PDF kuju ja digiallkirjastatud kiri on lisatud.

**Operatsioon CH (juuli - oktoober 2022)**

Agendi nimi: K.P.; X.X.; X.X.; X.X.; X.X.; X.X.; X.X.; X.X.; X.X.; X.X.; X.X.

Koosseis: Tõendi kunstlik loomine karistatav viieaastase vangistusega (Karistusseadustik §316) seoses altkäemaksu andmisega erasektoris karistatav viieaastase vangistusega (Karistusseadustik §402\_4)

**Operatsioon AB (november 2022 - märts 2023)**

Agendi nimi: M.W.; X.X.; X.X.; X.X.; X.X.; X.X.; X.X.

Koosseis: "honey-trap" olukord (20-aastane venelanna, selgelt šokis) ja laboratoorsete tõendite kogumine narkootiliste ainete kasutamisest; osalesid agendid, kes teesklesid end olevat Austria, Soome, Saksa, Poola, Ungari, Prantsusmaa ja Eesti Salapolitsei teenistujad.

e. Short overview of more serious attacks against Eero Saava

- Female operatives typically with initials X.X.
- June 2023 - 2024 period related heavy attacks are not covered at this moment (i.e. Brussels/Belgium; Antibes/France; Helsinki/Finland; Lille/France)

**Operation RE (27 November 2014 - present day)** Name of the Operative: P.I.

Set-up: unlawful surveillance activities and covert collection of information punishable by 3 year's imprisonment related #31 (Estonian Penal Code §315); fraudulent creation of evidence punishable by 5 year's imprisonment related #25 and #31 (Penal Code §316)

**Operation OR (15 Oct - 12 Nov 2021)**

Name of the Operative: W.K., X.X.

Set-up: To compile compromising dossier as if Eero Saava were accusing **Estonian MoD (Defence)** of corruption during the 1.5 h meeting in 10 Nov 2021. Eero Saava reacted within 24 hours and wrote a letter to Mol (Interior) and MoD. This letter in its both forms (PDF and digitally timestamped, software from [www.id.ee](http://www.id.ee)) is appended.

**Operation CH (July - October 2022)**

Name of the Operative: K.P.; X.X.; X.X.; X.X.; X.X.; X.X.; X.X.; X.X.; X.X.

Set-up: Fraudulent creation of evidence punishable by 5 year's imprisonment (Penal Code §316) related to giving of bribe in private sector punishable by 5 year's imprisonment (Penal Code §402\_4)

**Operation AB (November 2022 - March 2023)**

Name of the Operative: M.W.; X.X.; X.X.; X.X.; X.X.; X.X.; X.X.

Set-up: Honey-trap situation (20 yo Russian beauty, clearly coerced) and obtaining laboratory evidence of intoxication; Usage of Operatives pretending to be Austrian, Finnish, German, Polish, Hungarian, French and Estonian members of respective Secret Police.

### Deemonlik operatsioon Narkar-Joel (detsember 2022 - märts 2023)

Koosseis: Eero Saava tütar rünnati raudkangiga (tänapäevase psüühikahäirega); Planeeriti Eero Saava kohalejõudmist kuriteopaika enne politseipatrulli kohalejõudmist; Kriminaalidel õnnestus "kutsuda esile ime" ja viivitada politseipatrulli saabumist; Eero Saava pidi näost näkku kohtuma raudkangiga varustatud narkomaan Narkar-Joel'iga enne politseipatrulli saabumist, et luua kunstlik tõend Eero Saava seotusest Eesti narkomaffiaga; Karistusseadustik §184(2\_1) narkootilise aine suures koguses ebaseaduslik käitlemine suure varalise kasu eesmärgil, karistatakse eluaegse vangistusega.

### Operatsioon äiapapa 80 aasta juubel (18 - 19.02.2023)

Koosseis: Eero Saava pidi eelduslikult osa võtma; Kavandati suure koguse narkootilise aine peitmist eravaldusesse, et selle järel viia läbi politsei eriuksuste poolt läbiotsimine suurte jõududega; Karistusseadustik §184(2\_1) narkootilise aine suures koguses ebaseaduslik käitlemine suure varalise kasu eesmärgil, karistatakse eluaegse vangistusega.

#### f. Peamised põhjused USA asutuste kaasamiseks

- Majandusmõrtsukad on väikese riigi jaoks liiga võimsad, et nendega ilma liitlasteta toime tulla. Majandusmõrtsukad võivad sekkuda üle maailma energeetikasse ja muuta elektri hinna tarbijatele talumatult kalliks.
- Välisinvesteeringu usaldusväärsuse hindamise seadus (lühend VUHS, vastu võetud 25.01.2023) eelistab Euroopa Liidu investoreid USA investoritele. USA investorid võivad saada kergesti ametliku eitava vastuse oma investeerimissoovile tuuleelektrijaama, mille võimsus on üle 200 MW.

### Demonic Operation Joel-the-Junkie (December 2022 - March 2023)

Set-up: Daughter of Eero Saava was attacked with iron bar (psychological damage has still not been healed); Eero Saava was supposed to arrive to the crime scene before the police patrol; Criminals 'miraculously' succeeded in delaying the arrival of the police patrol; Eero Saava was supposed to meet face-to-face with the iron bar attacker Joel-the-Junkie before the arrival of the police patrol to fabricate evidence of his connectedness with the Estonian drug lords; Penal Code §184(2\_1) Unlawful handling of large quantities of narcotic drugs for the purpose of significant proprietary benefits punishable by life imprisonment.

### Operation Father-in-law 80th birthday (18 - 19 Feb 2023)

Set-up: Eero Saava was supposed to participate; Large quantities of narcotic drugs were planned to be planted into private property, to be raided with full Estonian SWAT power; Penal Code §184(2\_1) Unlawful handling of large quantities of narcotic drugs for the purpose of significant proprietary benefits punishable by life imprisonment.

#### f. Main reasons for US agencies to assess helping Estonia

- Economic Hitmen are too powerful for a small nation to be managed without allies. Economic Hitmen can interfere with energy investments all over the world, and cause the electricity prices to skyrocket.
- Estonian Foreign Investment Reliability Assessment Act (passed 25 Jan 2023) prefers investors from European Union and hinders investors from USA to get official approval to invest in wind electricity power plant larger than 200 MW.



Mõne Eesti eksperdi jaoks tundus VUHS "kummaline". Tuleks ametlikult uurida, kas Majandusmõrtsukad üritavad USA investoreid, ja ka USA tipptehnoloogia ettevõtet **General Electrics**, Eesti meretuuleparkide sektori poolt pakutavatest võimalustest eemal hoida.

Some Estonian legal experts found the Foreign Investment Reliability Assessment Act 'strange'. It is advisable to investigate whether Economic Hitmen are trying to block investors from USA, including technology giants such as **General Electrics**, from the opportunities created in the Estonian offshore wind energy sector.
